SUBJECT: -Extension of General Affiliation up to Secondary Level.

This is with reference to school application on the subject cited above. In this connection, I am directed to convey the approval of the Board for Extension of General Affiliation as per details given below:-

Sl. No.	The school is directed to ensure that :
1	School has provided two separate land certificates dated 13.06.2023 issued by the DM, Itanagar one comprising the land 1250 Sqmtr. and other 500 Sqmtr where it is not established that the both of the plot are in adjacent and comprising a single plot. School shall obtain the one land certificate of 1750 Sqmtr. From the concerned authority and upload on the SARAS portal as compliance within 03 months.
2	It is noticed in the video that the school has hill slope on the side of play ground and some area under the slope is not covered with the boundary wall, any trespassing is not possible from that side but keeping in view the safety and to stop direct access of the students the area may be covered with the fence and upload on the SARAS portal as compliance within 03 months.
3	Math lab appears undersized and understocked. Few dimension shapes are placed on a tables as makeshift arrangement. Adequate seating and activity tables are not available in the math lab to accommodate 40 students at a time and conduct practical. School shall setup the lab in the light of SoP within 03 months and submit compliance on SARAS portal.
4	Library appears undersized and understocked. Separate reading area for teachers is not developed and ICT infrastructure is not installed in the library. School shall add collection of classics, autobiographies, biographies, travelogues, essays, fiction, poetry, drama, recreational and motivational materials. Dictionaries, encyclopedias, yearbooks, children's magazines, illustrations, maps and charts, other reference materials and install ICT infrastructure to cater the need of access digital/cloud reading material within 03 months and submit compliance on SARAS portal.
5	The school shall ensure the mandatory training of its teachers with CoE, CBSE, Guwahati within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.

If the compliance is not submitted within the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.


